2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

WARNING! CAUSES EYE IRRITATION, MAY IRRITATE SKIN, RESPIRATORY TRACT, AND GASTROINTESTINAL TRACT. HARMFUL IF SWALLOWED.

4. FIRST AID MEASURES

EYE CONTACT: Get medical attention immediately. Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 15 minutes.

SKIN CONTACT: Get medical attention for irritation. Wash with plenty of water. Remove contaminated clothing and shoes. Continue to rinse for at least 15 minutes. Wash clothing before reuse. Clean shoes thoroughly before reuse. Destroy contaminated shoes.

5. FIRE FIGHTING MEASURES

NOTE: Solid product. Product will melt and combustion may occur when exposed to fire.

General information: As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. During a fire, irritating and highly toxic gases may be generated by thermal decomposition or combustion. Use water spray to keep fire-exposed containers cool.
